

## 1. BHU Response:

A detailed point wise clarification submitted to the Registrar, Banaras Hindu University vide letter No. WEUPPL/MZP/MoEF/2014/1 dated 29/01/2014. A copy of the same is enclosed as Annexure # 1 for your ready reference.

#### 2. Reply Sought by PMO Office:

3. Relevant documents on Port & Railway Authorities & MOU/Agreement: In respect handling imported coal, we have signed MOU with Dhamra port. Regarding Rail transportation Clearance, we would like to inform that there will be no RTC issued from Ministry of Railways as per MOR circular dated 23<sup>rd</sup> July 2012 which states that "there will be no requirement of RTC for power plants (IPPs & CPPs)" Zonal Railway may examine the siding proposals incorporating the traffic flow & approve the same under intimation to Railway Board '

Zonal Railway has asked to submit the Fuel linkage document for granting RTC, the same has been submitted to them. RTC is under due consideration with North Central Railways and expected soon. A copy of internal correspondence is enclosed herewith as Annexure # 3B for your ready reference & record.

## 4. Firm Water Availability in Lean Season:

The details of firm water availability especially during the lean season for the power project and water source availability for the entire year is attached herewith as Annexure # 4.
